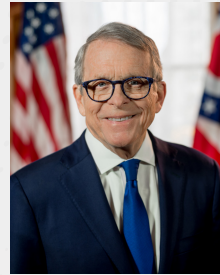

Study Overview

JobsOhio commissioned this statewide economic impact study of the Ohio defense-related industries to identify and promote the economic value of the state's defense-related assets. This study employs industry standard econometric forecasting models and publicly available spending data to provide direct, indirect, and induced economic impact estimates at the state and regional level. Estimates were developed for each member region in the JobsOhio Regional Network. The study considers military and federal spending, both on and off installations, which includes military and federal contractors not associated with an installation, as well as benefits received by veterans and military retirees residing in-state, and the operations of each of the Veteran Affairs Medical Centers located across the state. Data was primarily collected from the U.S. Department of Treasury, U.S. Department of Defense (DoD), U.S. Department of Veterans Affairs (DVS), U.S. Department of Homeland Security (DHS), National Aeronautics and Space Administration (NASA), Ohio National Guard, U.S. Bureau of Economic Analysis, U.S. Bureau of Labor Statistics, and the REMI PI+ econometric forecasting model.

In 2020, total military and federal spending in Ohio was roughly \$22.20 billion. As can be seen from the chart to the right, just over 35% of these dollars were transfer payments flowing to the 741,600 veterans and military retirees residing in Ohio. Another 35% came in the form of procurement contracts in support of the state's military installations and the off-installation contractors developing weapons systems, conducting research and development, and providing a litany of other military support services. The remaining 30% of spending went to the men and women serving our nation in the form of annual compensation - including active duty, government civilian, National Guardsmen, and reservist stationed throughout the state.

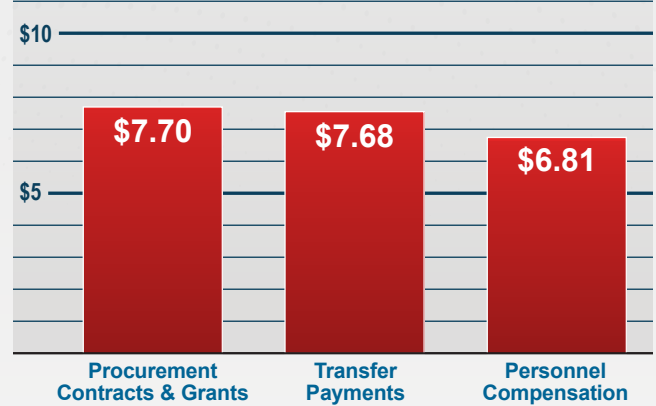
The economic impacts presented in this booklet capture the multiplier effect of military and federal spending flowing through the state's economy. These estimates were generated using the REMI PI+ econometric forecasting model. The model measures the direct, indirect, and induced economic effects of Ohio's military and federal sector as well as the trade flow effects occurring between each of the state's six regions. In total, the 2020 military and federal spending supported an estimated 380,500 jobs, nearly \$40 billion in gross regional product and represents \$69 billion in total economic activity - accounting for nearly 6% of the state's economy.

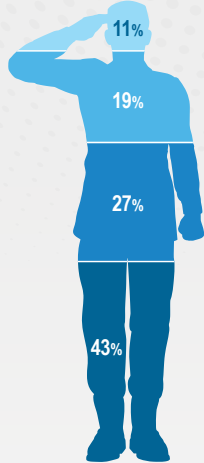

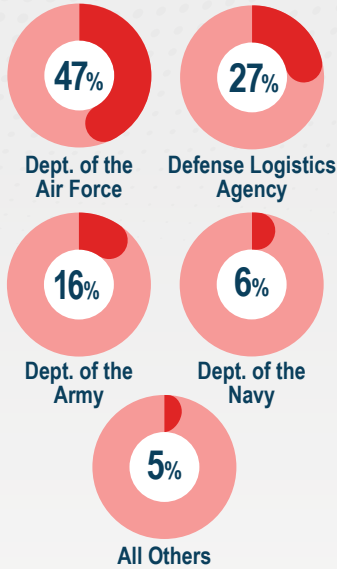

Personnel by Type

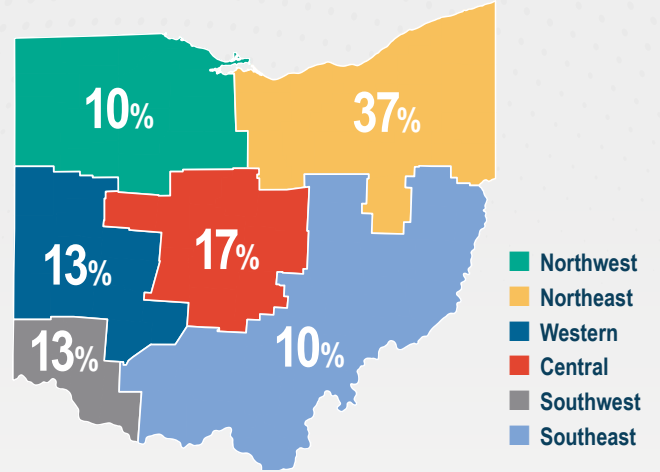

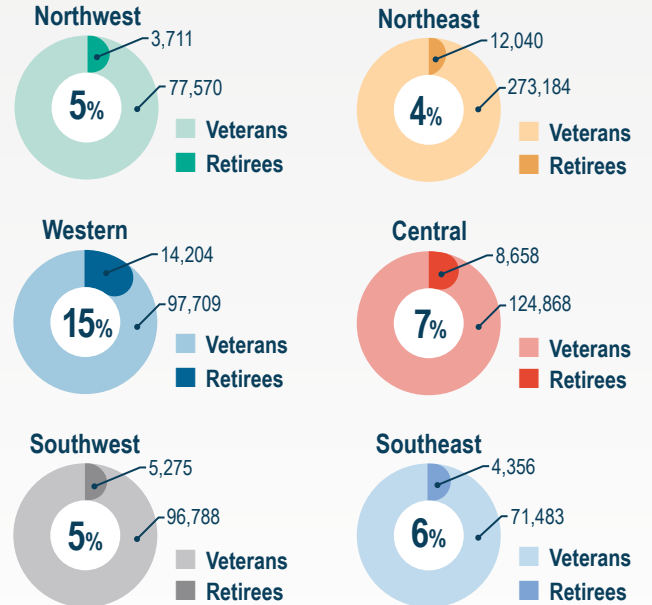
Defense Contracts by Awarding Office



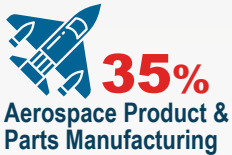
Veteran Distribution by Region



Percentage of Regional Veteran Population that are Military Retirees

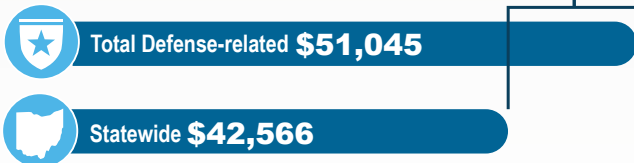

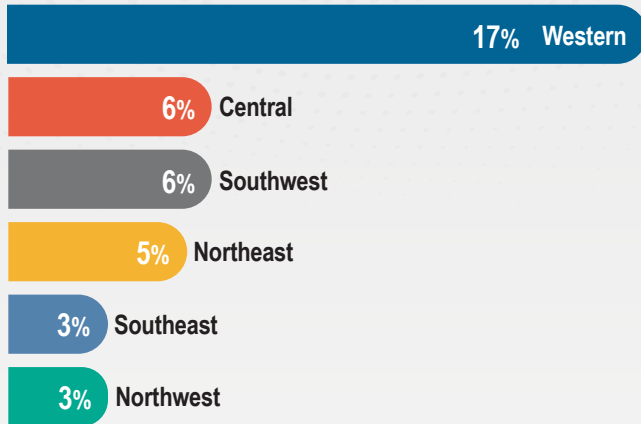

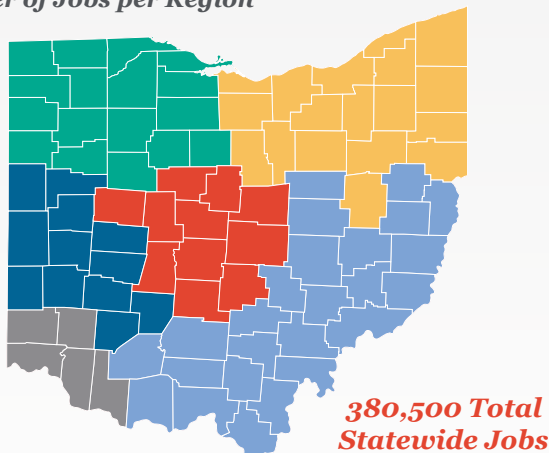
Military & Federal Spending as a Percentage of Each Region's Economy

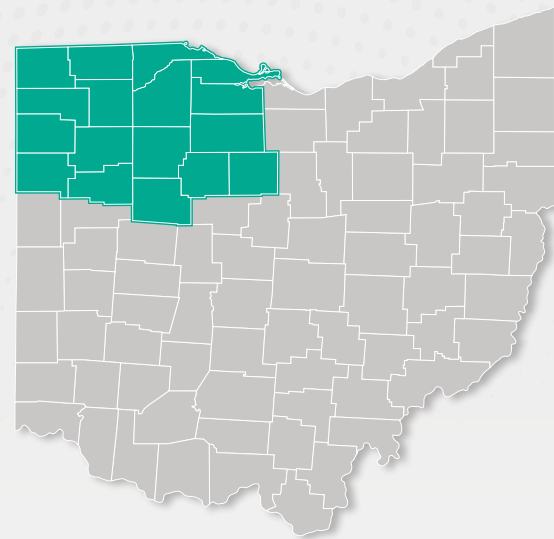

The Northwest region of Ohio is home to the Joint Systems Manufacturing Center (Lima) as well as the Ohio National Guard units who train at Camp Perry and those attached to the Toledo Express Air National Guard Base. Additionally, more than 77,500 veterans reside in the region, of which 3,700 are military retirees.

Total direct military and federal spending was approximately \$960 million in 2020 - \$240 million in procurement contracts, \$166 million in military and civilian compensation, and \$558 million in pensions & transfers to the region's veterans and military retirees.

Military and federal activities and investment supported roughly 18,000 jobs and \$1.8 billion in regional economic impact, which accounts for 2.62% of the region's economy. Although this spending supports less than 3% of the region's economy, many of the jobs tied to this sector offer wages higher than the state average.

Northwest Region

Joint System Manufacturing Center – Lima

Allen County

Joint System Manufacturing Center (JSMC) is a subordinate unit of the Tank-Automotive & Armaments Command (TACOM) and home to the Program Executive Office Ground Combat System (PEO GCS). JSMC is a U.S. Army Government Owned, Contractor Operated (GOCO)

facility operated by General Dynamics Land Systems that provides the Department of Defense (DoD) with the manufacturing, repair, and refurbishment of heavy and light armored combat vehicles. The JSMC specializes in cost effectiveness and responsiveness alongside the private industry, while maintaining control of equipment for preservation of mission readiness. In particular, the JSMC produces combat vehicles and their components for the M1 Abrams Family, the hull structure of the Namer Armored Personnel Carrier, hull structures for the Stryker Family of Vehicles, and MK 46 Naval Weapons Gun Station turrets.

Camp Perry Joint Training Center

Ottawa County

Camp Perry is a National Guard training facility and home to the 213th Ordnance Company, the 372d Missile Maintenance Company, the 200th RED HORSE Squadron, U.S. Coast Guard Port Security Unit 309 and the Ohio Naval Militia. Camp Perry's various squadrons come with a multitude of missions including highly mobile engineering, logistics, and construction capabilities and units to patrol Lake Erie and their overwater range. Additionally, Camp Perry hosts a Civilian Marksmanship Program, the National Rifle Matches, and is also home to the second longest shooting range in the country.

Toledo Express Air National Guard Base

Lucas County

Located in Swanton, the Toledo Air National Guard Base (ANGB) and its host unit, the 180th Fighter Wing, are currently charged with protecting the homeland through effective combat power and defense support to civil authorities as well as developing Airmen, supporting their families, and serving in the community. More specifically, the 180th Fighter Wing engages in both the Fighter and Air Sovereignty Missions developing pilots who can defend the U.S. and its allies through air-to-air and air-to-ground operations. These operations are designed to support ground forces and gain control of enemy airspace while protecting American airspace using early detection radar systems and eliminating any threats using F-16 Fighting Falcon aircraft assigned to the Wing.





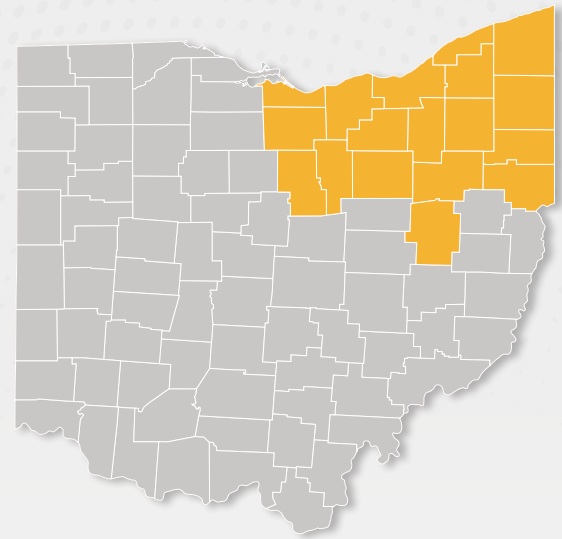

The 18-county region of Northeast Ohio is home to a variety of military installations, veterans support services, research facilities, and DoD's "Fourth Estate" functions. Military installations include Youngstown Air Reserve Station, Mansfield Lahm Air National Guard Base, and Camp Garfield; veterans support services include the Louis Stokes Cleveland VA Medical Center; research facilities include those at NASA's Glenn Research Center; and, the DoD's Defense Finance Accounting Services located in Cleveland. The region is also home to 37% of the state's veterans with more than 273,000, of which over 12,000 are military retirees.

In all, more than \$5.5 billion in military and federal spending was realized in 2020. Given the region's large veteran population, nearly 50% of this spending came as pensions and transfers to veterans residing in-region; more than 30% came in the form of compensation for the region. Additionally, more than 30% came in the form of compensation for the region's military and civilian employees while 20% went to the procurement contracts performed in the region.

This \$5.5 billion in direct spending translated to roughly 108,500 jobs, \$10.6 billion in regional economic impact, and \$18.3 billion in gross output. These economic impacts constituted approximately 4.5% of the region's total economy in 2020.

Northeast Region

Glenn Research Center, NASA

Cuyahoga County

The Glenn Research Center, located at Lewis Field in Northeast Ohio, has designed and developed innovative technology for advancing NASA's missions in aeronautics and space exploration since its formation in 1942. The unique facilities at Glenn Research Center enable NASA, other government agencies, and partners in the academic and industrial spaces, to perform specialized research and training. One of these partners includes the Boeing Space Launch System (SLS) responsible for the design, development, and delivery of the hydraulic system in the Core Stage of the SLS, the nation's next human-rated rocket that will transport people and cargo to deep space. Besides their dozen or more missions in research and development, Glenn Research Center also provides high school students with internships and competitive experiences through the Lewis' Educational and Research Collaborative Internship Program (LERCIP) and the annual Dropping in Microgravity Environment competition in which selected teams perform experiments in the Zero Gravity Research Facility. Glenn currently employs over 1,600 federal civilians and over 1,500 contract employees.

VA Northeast Ohio

Cuyahoga County

Headquartered within the Louis Stokes Cleveland VA Medical Center, the 5,497 employees of Northeast Ohio's VA Healthcare System served 111,538 veterans across 21 counties throughout the region in 2020. The 18 care locations in Northeast Ohio include 13 outpatient clinics, two community resource and referral centers, a psychosocial rehabilitation and recovery center, a chronic dialysis center, and an outpatient surgery center. The main focus of the healthcare system is to treat veterans through health promotion and disease prevention by providing comprehensive, seamless health care and social services. Additionally, VA Northeast Ohio supports the future of medicine through strong education, training, and research programs, with the ultimate goal of providing the safest and highest quality health care to our nation's veterans.

Defense Finance Accounting Service Cleveland

Cuyahoga County

Situated within the Anthony J. Celebrezze Federal Building, Defense Finance Accounting Service (DFAS) Cleveland is part of one of the world's largest accounting and finance operations. The primary mission of DFAS Cleveland is to provide the best accounting and financial services in support of the Soldiers, Sailors, Marines, Airmen, Guardians, and federal civilians who defend America. With 2,250 operational employees and 400 corporate employees, DFAS Cleveland currently handles pay services for the active and reserve components of all military branches, retirees & annuitants, and federal civilian employees.

Northeast Region

Youngstown Air Reserve Station

Trumbull County

Youngstown Air Reserve Station (YARS) is home to the 910th Airlift Wing and the DoD's only large area fixed-wing aerial spray capability to control disease-carrying insects, pest insects, undesirable vegetation and to disperse oil spills in large bodies of water. Its C-130 Hercules aircraft are used daily across the Country and around the world to perform tactical and humanitarian airlift, and aerial spray missions. YARS is also home to the Youngstown Civil Air Patrol (CAP), a youth leadership development program centered around aviation and the military.

Mansfield Lahm Air National Guard Base

Richland County

At Mansfield ANGB there are several active missions. The focus of the 179th Airlift Wing (179 AW) is Air Mobility, a mission that delivers global air transportation of equipment, supplies, personnel, or dignitaries during times of war and for peace-time training exercises. In addition, the 179 AW also participates in disaster relief efforts and other domestic/overseas emergencies as commanded. A Detachment of the 200th RED HORSE Squadron is also stationed at Mansfield ANGB, standing ready to provide a highly mobile civil engineering response forces that includes heavy repair and construction capabilities to support contingency and special operations missions worldwide.

Camp Garfield

Portage County

Camp Garfield is a National Guard military base and Joint Military Training Center located in Ravenna, Ohio. Camp Garfield's main purpose is to facilitate unit readiness requirements. Its abundance of training assets and state-of-the-art digital training equipment, spread across 21,000 acres, provide for a realistic combat training environment for Pre-Mobilization, Inactive Duty Training, and Annual Training Events. With improved features such as a Fire and Movement Range, Automated Record Fire Range, and Training Aids, Devices, Simulators, and Simulation (TADSS), Camp Garfield has become one of Ohio's premier training installations.

U.S. Coast Guard 9th District

Cuyahoga County

The Ninth Coast Guard District of Ohio is currently located at the Anthony J. Celebrezze Federal Building in Cleveland, OH. The Ninth Coast Guard District, also known as The Guardians of the Great Lakes, is in charge of all Coast Guard Operations amongst the five Great Lakes, the Saint Lawrence Seaway, and large portions of surrounding states that include 6,700 miles of shoreline and 1,500 miles of the international border with Canada. Under the charge of a rear admiral, the roughly 6,000 active duty, reserve, civilian, and auxiliary men and women who comprise the Ninth Coast Guard District are responsible for the delivery of multi-mission services related to search and rescue, maritime safety and security, environmental protection, maritime law enforcement, aids to navigation, and ice-breaking. Geographically, District Nine is subdivided into five sub-sectors who are then made up of 48 active stations, various Air Stations and Cutters, several Marine Safety Units, and a handful of Aids to Navigation Teams.



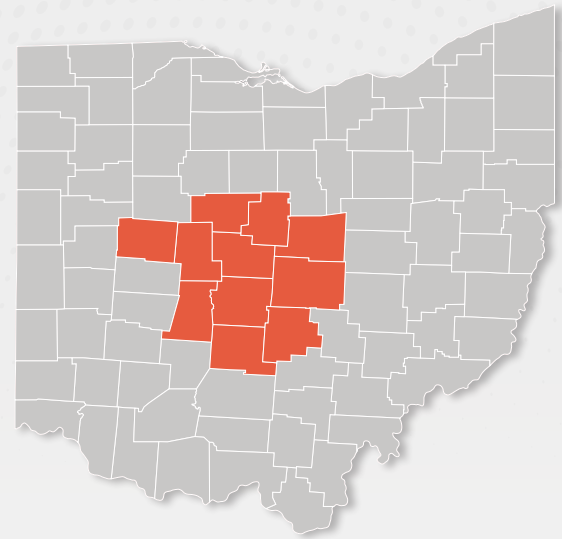

The Central Region is made up of 11 counties with several military installations and DoD "Fourth Estate" functions. Military installations include Ohio National Guard Headquarters, Rickenbacker Air National Guard base and several smaller Guard armories. "Fourth Estate" functions include Defense Finance Accounting Service-Columbus, Defense Information System Agency, Defense Logistics Agency Land and Maritime, and Air Force Meteorology and Calibration. The region is also home to the Columbus VA Ambulatory Center which supports the region's 124,900 veterans.

The region received nearly \$3.5 billion in spending during 2020. Spending was spread roughly the same across the three components with procurement contracts constituting just under 30%, compensation at 35% and pensions & transfers making up the remaining 35%.

In terms of military and federal impacts on the economy, these dollars supported nearly 76,000 jobs, \$7.6 billion in regional economic impacts, and \$12.9 billion in gross output. This represents roughly 5.6% of the region's total economy.

Central Region

Defense Finance Accounting Service Columbus

Franklin County

Located on the Defense Supply Center Columbus (DSCC) installation, DFAS Columbus is the Center of Excellence for Acquisition Accounting, the largest customer mission area within DFAS. When it comes to large purchases within the DoD, DFAS Columbus makes both the contract payments and performs all related accounting processes. In addition to Acquisition Accounting, DFAS Columbus also hosts the key functions in Travel Pay and Accounting Operations in the following areas: Accounts Payable, Accounts Receivable, Accounts Maintenance, Control and Departmental Reporting, Customer Call Center, and System Operations. Major Defense agencies' accounting and related vendor pay work are also located at DFAS Columbus. Overall, the centralized organizational structure and managerial oversight of the entire end-to-end process provide DFAS Columbus with significant procedural efficiencies.

Defense Information System Agency

Franklin County

The Columbus branch of the Defense Information System Agency (DISA) is part of a larger entity of DISA that spans 25 states and 7 countries, employing roughly 19,000 people. DISA's main responsibilities include the planning, engineering, acquiring, testing, fielding, operations, and assurance of information-sharing capabilities. DISA provides the Department of Defense and national leadership with command-and-control solutions and a global enterprise infrastructure. With the ultimate goal of becoming the trusted connection and protection for the warfighter in cyberspace, DISA's mission is to conduct Department of Defense Information Network's operations for the joint warfighter to enable lethality across all warfighting domains in defense of the United States.



Central Region

Defense Logistics Agency Land and Maritime Franklin County

Based in Columbus, Ohio, Defense Logistics Agency (DLA) Land and Maritime is part of the greater DLA which serves as our nation's combat logistics support agency by managing the end-to-end global defense supply chain for the six military services, 11 combatant commands, other federal/state/local agencies, and allied nations. DLA responsibilities include the procurement and transportation of items for the DoD and other customers, the direct contract ordering of items needed by the military, and the disposition of excess military property and equipment. DLA Land and Maritime, in particular, manages the supply chain for ground-based and maritime weapons systems' repairs parts, small arms parts, and fluid-handling systems. DLA's overarching mission is to deliver readiness and lethality to warfighters and support the nation with quality, proactive, and global logistics.

Rickenbacker Air National Guard Base Franklin County

Home to the 121st Air Refueling Wing (ARW), and several other missions, Rickenbacker ANGB and the host Wing's primary objective is to provide in-flight refueling, using the KC-135 Stratotanker, to extend the flying range of an array of air-based capabilities for the U.S. Armed Forces and allied nations. At Rickenbacker, the homeland defense mission entails the provision of life-saving capabilities in the event of a national emergency resulting from natural or manmade disasters. Rickenbacker's third mission provides weather forecasts that allow commanders to maximize resources by using accurate and relevant battle-space information.

Central Region

Air Force Metrology and Calibration

Licking County

The Air Force Metrology and Calibration's (AFMETCAL) main mission is to acquire and sustain precision measurement capabilities while operating a worldwide calibration network to ensure accurate, reliable, and safe air and space systems performance. To achieve this, AFMETCAL manages metrology and calibration for the Air Force to ensure systems are accurate, uniform, reliable, and traceable to the National Institute of Standard and Technology (NIST). Additionally, AFMETCAL is responsible for the development, acquisition, and sustainment of Air Force Primary Reference Standards and Base Reference Standards for both the Air Force Primary Standards Laboratory (AFPSL) and Precision Measurement Equipment Laboratories (PMELs) worldwide. AFMETCAL also provides the central management and day to day support of PMELs worldwide which include dealing with facility logistics, staffing, contracting, and financial issues as well as programmatic policy and guidance responsibilities.

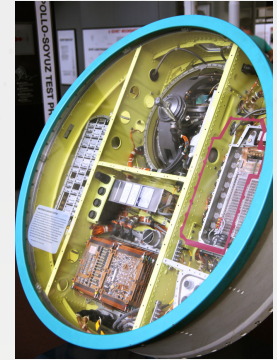

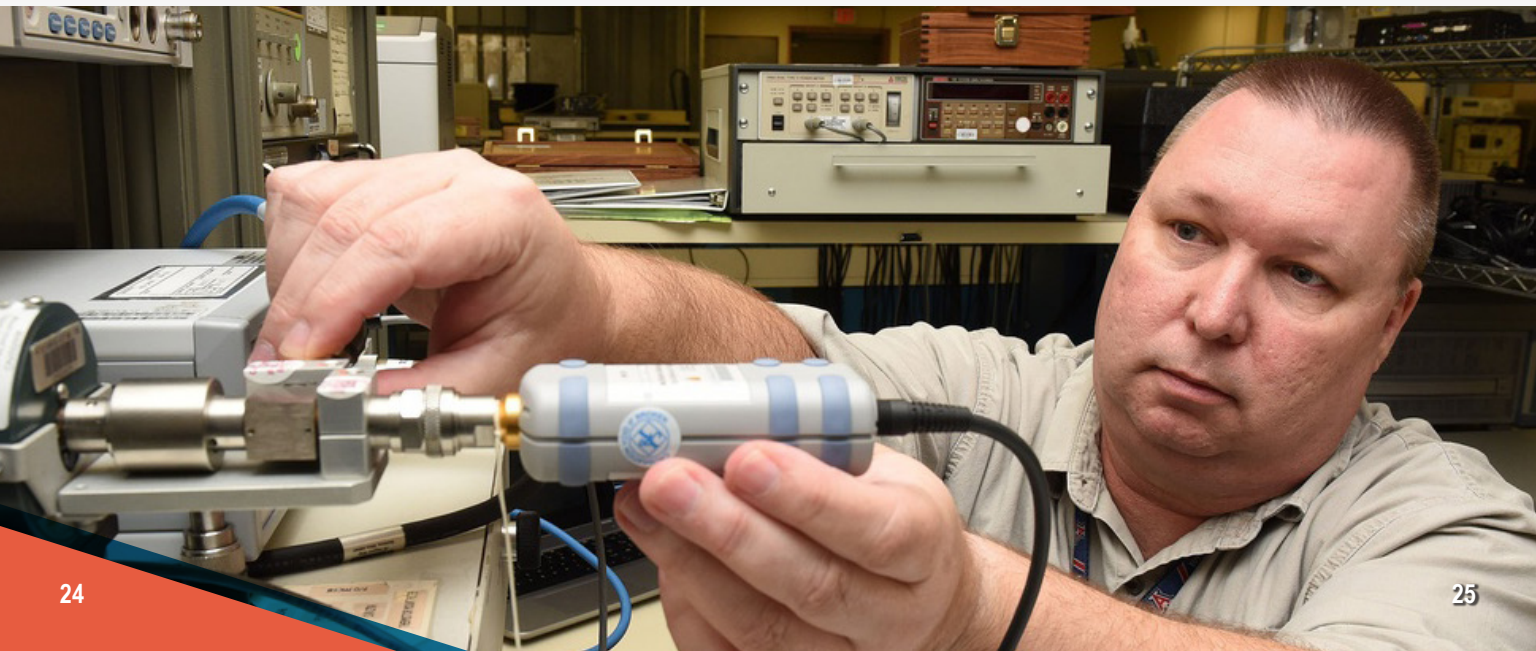
Boeing Guidance Repair Center

Licking County

Located in Heath, Boeing's Ohio headquarters, the Guidance Repair Center's core business activities include the repair of guidance and navigation electronics for the U.S. Department of Defense. Specific operations and missions include the repair and maintenance of the Minuteman III Intercontinental Ballistic Missile guidance system, as well as the assembly, integration, and testing of the Minuteman III Flight Test, Telemetry, and Termination System. Further operations include the repair and maintenance of the avionics and navigation systems found on most U.S. Air Force aircraft, the production and repair of several aircraft subsystems, and the repair and maintenance of the U.S. Navy's Trident navigation system, Electrostatically Suspended Gyro Navigator (ESGN), and Stable Platform Housing for the strategic nuclear submarine fleet.

16th Engineer Brigade

The 16th Engineer Brigade provides command and control of assigned subordinate units/teams. They assist maneuver and support brigades by executing, coordinating, and directing mobility, counter-mobility, and survivability tasks and providing support to general engineering missions. They enable tailored force packages to be applied to a specific mission group, focused logistics, and constructive force protection. Finally, it reinforces engineers in maneuver brigade combat teams.



37th Infantry Brigade Combat

The 37th Infantry Brigade Combat Team's mission is to provide command, control and supervision of the operation of the brigade and attached units.



174th Air Defense Artillery Brigade

The 174th Air Defense Artillery Brigade's mission is to command and coordinate the operations of subordinate air defense artillery battalions and other assigned and attached units in the theater army.



73rd Troop Command

The 73rd Troop Command provides command, control and support of subordinate units during premobilization (peacetime) training and non-deployed (steady state)/domestic operations in order to maintain readiness and mission-essential task list proficiency for eventual mobilization/deployment in agreement with the adapted sustainable readiness model.



Special Troops Command (Provisional)

Special Troops Command (STC) supports Ohio Army National Guard units through all phases of sustainment, restoration, and modernization, so that units are ready to mobilize in support of contingency operations and in support of the National Military Strategy. STC provides support to all Ohio Army National Guard units when called by the governor. The STC provides organized, trained, and equipped units to protect life, property and to preserve peace. STC Soldiers participate in national, state and local programs that support our communities.

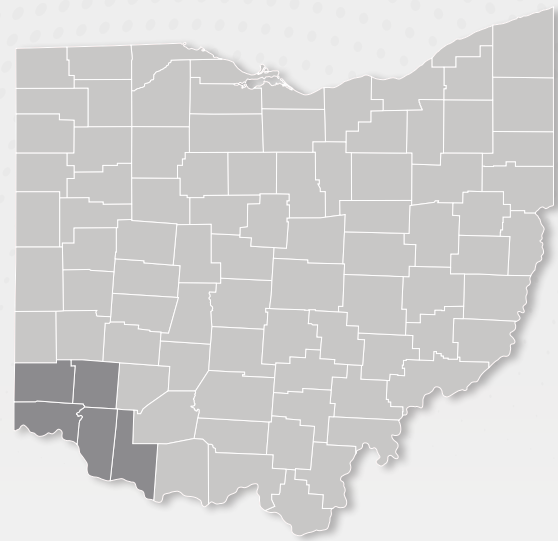

The Southwest Region is home to the Cincinnati VA Medical Center, the Great Lakes U.S. Army Corps of Engineers (USACE), and the Blue Ash Air National Guard Station. In 2020, the region received \$4.2 billion in direct military and federal spending. Approximately 70% or \$2.8 billion was from procurement contracts performed in-region, representing the largest share of procurement contracts in the state. Of the \$2.8 billion performed in-region, the General Electric Company performed just over \$1.8 billion with the vast majority being performed in the aerospace industry.

Nearly \$1 billion went to pensions and transfers in support of the 96,800 veterans and military retirees residing in-region. The remaining \$400 million in direct spending flowed to the region's federal civilians working at the Cincinnati VA Medical Center and the USACE as well as the handful of Guardsmen and reservists connected to the Blue Ash Air National Guard Station and Ohio National Guard facilities.

The \$4.2 billion in direct spending supported 58,600 jobs, \$6.7 billion in regional economic impact, and \$12.3 billion in gross output. This spending accounted for 5.7% of the region's economy and nearly 9% of all capital investment.

Cincinnati VA Medical Center

Hamilton County

Unlike other VA medical centers within Ohio, the Cincinnati VA Medical Center consists of two divisions located in Cincinnati, OH and Fort Thomas, KY, serving 17 counties in Ohio, Kentucky, and Indiana with six Community Based Outpatient Clinics. Within the Cincinnati campus, there are three additional locations which include the Eye Center, Vet Center, and Mental Health Outreach Community Division. The Cincinnati VA Medical Center is an affiliated teaching hospital, providing a full range of patient care services, with state-of-the-art technology, medical education, and research. The Medical Center provides an array of primary care, dentistry, specialty outpatient services, and tertiary care in areas of medicine, surgery, psychiatry, physical medicine, rehabilitation, and neurology. Additionally, the Cincinnati VA Medical Center serves as a referral center for PTSD and offers multiple residential programs for treatment. The Medical Center also has an active affiliation with the University of Cincinnati College of Medicine and is connected both physically and functionally to the University, with over 500 fellows, residents, and students trained there.

The Great Lakes and Ohio River Division of the USACE, which uses the Project Management Business Process (PMBP) and operates in tandem with seven other USACE districts as a Regional

Business Center, provides project management, engineering, and contracting services across the full spectrum of operations in support of our national interests. USACE's mission is to deliver vital public and military engineering services, partnering in peace and wartime to strengthen our nation's security, energize the economy, and reduce risks from disasters. Some of the division's responsibilities include keeping the Ohio River system navigable, protecting the shorelines of the five Great Lakes, operating multiple dams, maintaining nine hydropower plants, employing an Emergency Management Team, cleaning up radiological waste, operating/maintaining inland navigation channels, and restoring/creating/preserving wetlands. They also support Army and Air Force installations, providing technical construction support, and conducting research and development in technologies that protect the nation's environment and enhance quality of life.

Blue Ash Air National Guard Station

Lucas County

Blue Ash Air National Guard Station is home to the 123rd Air Control Squadron (123 ACS), a mobile control and reporting element equipped with air surveillance radar, generators, tactical vehicles, point-to-point, ground-to-air, and satellite communications capabilities. Operationally, the 123 ACS provides Command and Control to assist ground force commanders in control of regional airspace while also directing joint-service aircraft and assisting in the planning, requesting, coordinating, and controlling of close air operations, intelligence gathering and airlift.

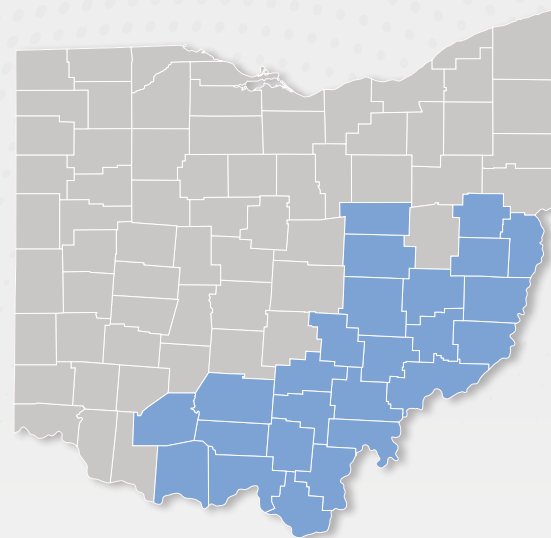

The Southeast region is home to the Chillicothe VA Medical Center, Zanesville Air National Guard base, and the Camp Sherman Joint Training Center. The region is also home to nearly 71,500 veterans and military retirees.

In 2020, the region received approximately \$1.2 billion in direct spending, of which 80% went to support the region's veterans and military retirees through pensions and transfer payments. The remaining \$260 million went toward operations at the Chillicothe VA Medical Center and local National Guard facilities.

This spending supported 16,300 jobs, generated \$1.6 billion in regional economic impact and \$2.8 billion in gross output. Given the vast majority of direct spending was realized as pensions and transfers, personal income in-region was greater than the regional economic impact as personal income is inclusive of federal transfers.

Southeast Region

Chillicothe VA Medical Center

Ross County

Situated on 308 acres of rural land and a beautiful campus-style facility, Chillicothe VA Medical Center provides acute and chronic mental health services, primary and secondary medical services, extended care, a wide range of nursing home care services, and serves as a chronic mental health referral center for other VA facilities in southern Ohio. Additionally, there are active ambulatory care services, individual mental health services, specialty medical services, and specialized women veterans clinics located onsite. The Chillicothe VA Medical Center also operates six Community Based Outpatient Clinics (CBOCs) throughout southeast Ohio. Community-based programs include Home Based Primary Care (HBPC), Care Coordination, Mental Health Intensive Case Management (MHICM), Community Nursing Home and a Community Residential Care Program. In terms of affiliations, a collection of in-state (Ohio) and out-of-state universities have partnered with Chillicothe VA Medical Center for the purposes of education, training, and research.

Zanesville Air National Guard Base

Muskingum County

On the Zanesville ANGB, the 220th Engineering Installation Squadron (220 EIS), a group of highly skilled guardsmen, are primarily focused on remaining ready to deploy worldwide to install and engineer ground communications-electronic systems as well as to remove and relocate old or outdated systems. Additionally, they are trained and equipped to deliver emergency and programmed mobile communications, as well as on-site system maintenance and modifications. The men and women of 220 EIS must adapt and respond to the communications information needs of community, state, and nation.

Camp Sherman Joint Training Center

Ross County

Similar to Camp Garfield and Camp Perry, Camp Sherman has been purposed as one of the state's Joint Training Centers as of 2009. Camp Sherman first found prestige as one of the earliest and the third largest training camp in the nation during World War I. Today, men and women of the Ohio Army National Guard prepare for state and federal missions outside and within the 35,000 square feet readiness center. Additionally, Camp Sherman provides training support to non-DOD law enforcement agencies and is available to local youth and educational programs.

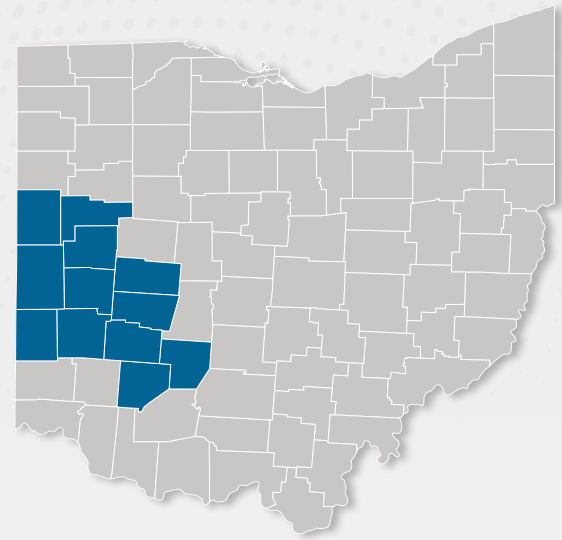

The Western Region is comprised of 12 counties and is home to Wright-Patterson Air Force Base, the Dayton VA Medical Center, and Springfield Air National Guard Base. In 2020, more than 97,500 veterans called the region home. With more than 14,200 military retirees, the region has the highest percentage of retirees at nearly 30%.

The region received nearly \$7 billion in total military and federal spending with more than \$3 billion in compensation to the region's military and civilian workers, \$2.5 billion in procurement contracts, and nearly \$1.4 billion in pensions & transfers.

Military and federal spending within the region surrounding Dayton supported just over 103,000 jobs and accounted for approximately \$11.6 billion in regional economic impact, and \$19.4 billion in gross output. These impacts translate to roughly 17% of the region's total economy. The vast majority of military and federal activities in this region can be attributed to the presence of Wright-Patterson Air Force Base, one of the largest Air Force bases in the country, and the largest single-site employer in Ohio.

Wright-Patterson Air Force Base

Greene County

Home to 15 different Air Force units, more than 100 associate units, and over 30,000 employees (including military, civilians, and contractors), Wright-Patterson Air Force Base (WPAFB) is the largest single-site employer within in the State of Ohio. WPAFB sits on more than 8,000 acres of land (12.5 square miles), maintains two runways, and supports roughly 47,000 aircraft sorties annually.

With such an enormous facility and employee base, WPAFB fulfills countless missions and purposes. The base is headquarters to a vast, worldwide logistics system, a world-class laboratory research function, and is the foremost acquisition and development center in the U.S. Air Force. Additionally, dozens of associate organizations, representing the Air Force and Department of Defense, can be found at WPAFB. Due to a wide range of economic activities including shopping, childcare, barbers, housing areas, a medical center, etc., some might consider WPAFB to be more akin to a medium-sized city than a military installation. WPAFB's host unit, the 88th Air Base Wing, performs the overarching installation management, maintaining infrastructure, training and deploying expeditionary Airmen in support of joint operations, and defending the base and its people.

A few of the major units at WPAFB include Headquarters Air Force Materiel Command (AFMC), Air Force Life Cycle Management Center (AFLCMC), Air Force Research Laboratory (AFRL), National Air and Space Intelligence Center (NASIC), the 445th Airlift Wing, Air Force Institute of Technology (AFIT), Air Force Installation Contracting Center (AFICC), and the National Museum of the Air Force. The responsibilities of these units are comprised of: weapon systems research and preparedness, aircraft and parts procurement, warfighting technology research and development, defense intelligence, medical support, mission support, defense-related education, acquisition solutions, and maintaining the oldest aviation museum in the world. Being the birthplace of aerospace, many major advances in aviation technology can be traced to WPAFB over the years. Because of its rich history in aviation, it is the underlying mission of WPAFB to continue to be the home and future for aerospace developments, to “keep ‘em flying faster, higher, farther and safer than man has ever flown before.”

Dayton VA Medical Center

Montgomery County

The Dayton Veteran Affairs Medical Center (VAMC) has served veterans for over 150 years, providing a full range of health care through medical, surgical, mental health (inpatient and outpatient), home and community health programs, geriatric (nursing home), physical medicine and therapy services, neurology, oncology, dentistry, and hospice care. Besides its 351 total operating beds, the Medical Center offers a variety of unique programs and services supporting geriatric evaluation and management, respite, Alzheimer's, home-based primary care, residential and outpatient PTSD, substance abuse, homelessness, sleep disorders, and women's health. To date the Dayton VAMC has contracts with Wright-Patterson Air Force Base and 11 area hospitals in addition to offering services in four community-based outpatient clinics in Lima, Middletown, Springfield, and Richmond (Indiana). Dayton VAMC's two primary missions are to provide Veterans a continuum of care that is accessible, value-added, cost-effective, and of the highest quality within an environment of outstanding education and research, and promote a culture that supports and develops a caring, compassionate, competent, and quality-oriented workforce. Moreover, as an indication of the medical center's importance, the VA opted to co-locate its history office on this VAMC's campus.

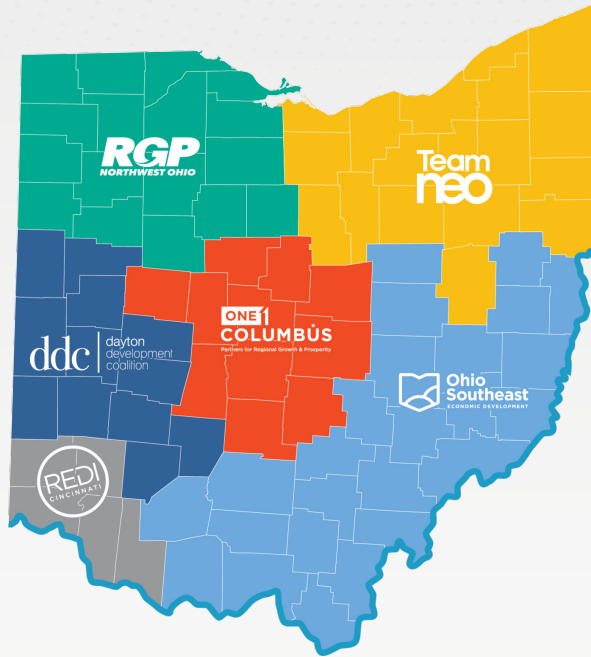
Springfield-Beckley Air National Guard Base

Clark County

On the Springfield-Beckley ANG Base there are four missions executed by three units: the 178th Wing, the 251st Cyberspace Engineering Installation Group, and the 269th Combat Communications Squadron. The 178th Wing is responsible for both the Flying Remotely Piloted Aircraft (RPA) and the Intelligence, Surveillance and Reconnaissance (ISR) missions. While operating the MQ-9 Reaper, the 178th provides close air support, air interdiction, ISR, and attack to eliminate threats when present. The diverse capabilities of RPAs allow for minimized danger and extended time over targets during Combat Search and Rescue (CSAR) operations. The 178th Wing gathers information regarding the enemy's movements, enabling mission success for commanders who must stay three steps ahead of enemy behaviors. The 251st employs programming and hardware advantages in order to detect and repel cyber-attacks on our computer systems and infrastructure, accomplishing the Cyber Systems part of the ISR efforts. The 269th's Ground Support & Combat Communications mission enables the deployment, operations, and maintenance of strategic emergency communications during war and state-declared emergencies. Additionally, the 371st Sustainment Brigade is located in Clark County and provides command and control for all subordinate units of the sustainment brigade, synchronizes current and future sustainment operations for the Expeditionary Sustainment Command (ESC) and Theater Sustainment Command (TSC).

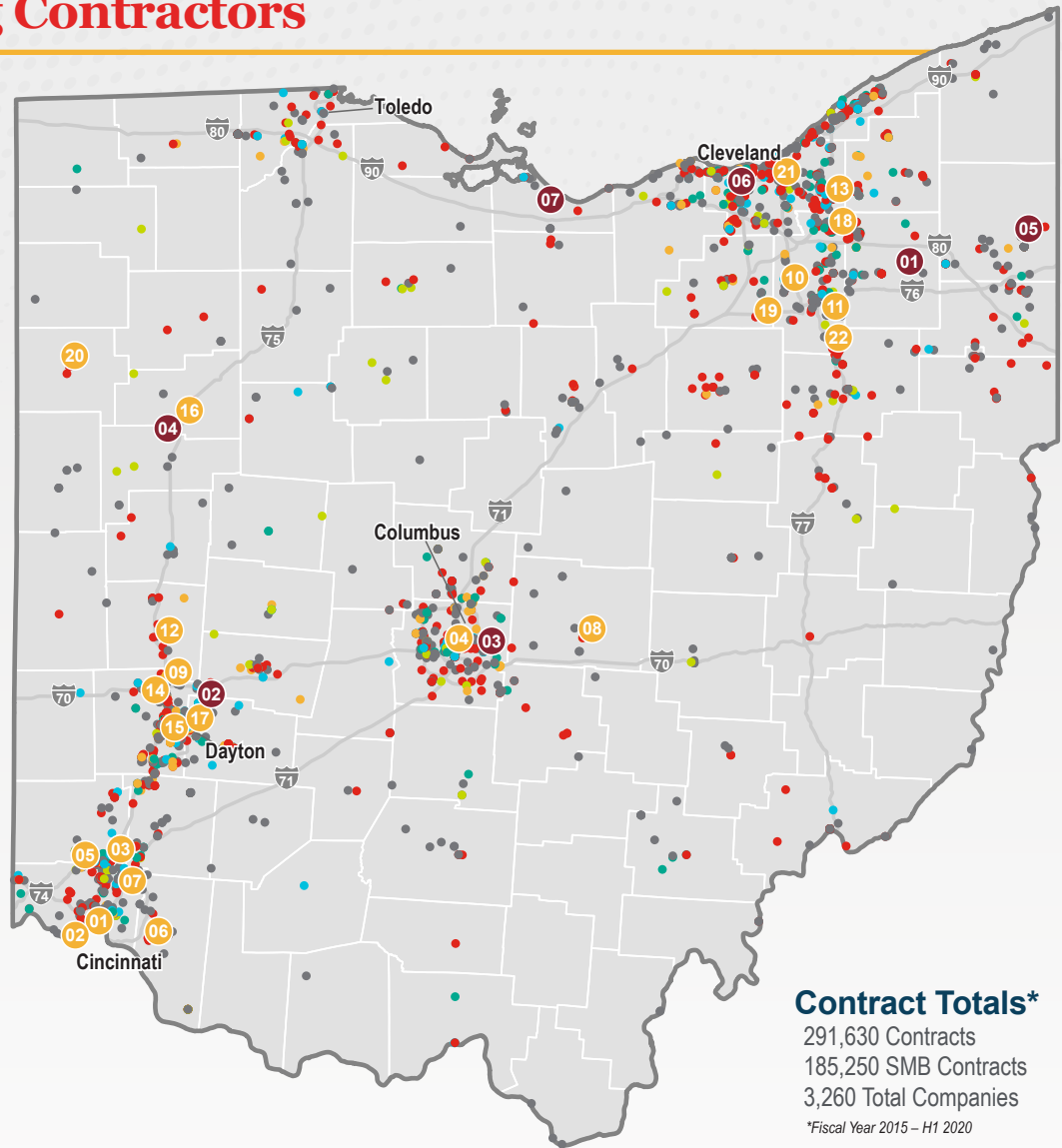

Term	Definition
Capital Investment	Purchases of residential and nonresidential structures and of equipment and software by private businesses and nonprofit institutions.
Direct Economic Impact	Direct impact includes all direct effects the organization has on the region due to the organization's operations.
Fourth Estate	Refers to DoD agencies not directly tied to a military service; includes, amongst others, the Defense Logistics Agency and the Defense Information Systems Agency.
Gross Output	The amount of production, including all intermediate goods purchased as well as value added (compensation and profit).
Indirect Economic Impact	The indirect impact includes the impact of local industries buying goods and services from other local industries. The cycle of spending works its way backward through the supply chain until all money is spent outside of the local economy, either through imports or by payments to value added.
Induced Economic Impact	The response by an economy to an initial change (direct effect) that occurs through re-spending of income received by a component of value added. This money is recirculated through the household spending patterns causing further local economic activity.
Jobs	Estimates of the number of full-time and part-time jobs supported by military and federal spending.
Personal Consumption	The goods and services purchased by individuals.
Personal Income	Income received by persons from all sources, including wages and salaries, benefits, proprietors' income, rental income, and transfer payments.
Regional Economic Impact	Net-value of goods and services produced by labor and property.
